- Practice Renewal Fee (if applicable)

(All Renewal Documents must be submitted electronically or postmarked and fees paid on or before July 1st of each year.)

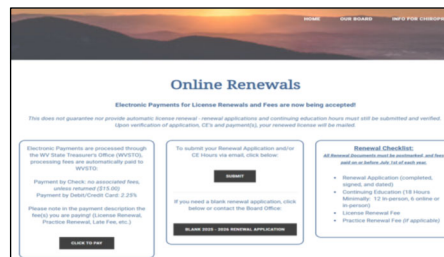
